in Government securities of the Central or State Governments, in fixed deposits, current accounts or other accounts in Scheduled Banks, in shares, debentures, bonds of fixed deposits of any public company or corporation incorporated in India or invest the trust funds in the purchase of any leasehold or freehold lands or buildings and in the construction of any buildings on any land belonging to the trust, as may be decided by the Board of trustees, provided however, that no investment shall be made in violation of the provisions of Sec. 11 of the Income Tax Act, 1961 or any other such relevant provisions of the law.






12. The Board of trustees shall have power to accept contributions in money or property either by way of additions to the trust funds generally or for any one or more of the specified objects of the trust and in either case such contributions shall be dealt with either as capital or as income according to the directions of the donors at the time of the gift.

13. The Board of trustees may borrow money from time to time from banks or other credit institutions of individuals at such interest and for such period and on such terms with or without security of movable or immovable properties of the trust as the Board of trustees may think fit and to secure the repayment thereof with interest by mortgage of the trust properties or by bond, promissory notes, bills and other negotiable securities or by issue of debentures.

14. The Managing trustee for the time being shall have power and authority to execute all documents for and on behalf of the trust provided the same has been approved by the Board of trustees by a resolution passed at a meeting or by circulations.



necessary and the meetings of the same shall be convened by the Managing Trustee on his own or by the Managing trustee on a request of any two of the trustees within two weeks of the receipt of such a request. The quorum of the meeting of the Board of trustees present shall be two and all decisions shall be by majority of the trustees present and voting except in the case of resolution passed by circulation when the same shall be deemed to have been passed if they are approved by the majority of the trustees for the time being. 16. The accounts of the trust shall be closed every year on the 31st day of March and the first close of accounts shall be on the 31st day of March 1994. The Statements of accounts for such year duly audited by the auditors of the trust appointed by the Board of trustees shall be placed before a meeting of the Board of trustees by the Managing trustee within four months of the close of accounting year.

17. The Managing trustee who shall be the executive Officer of the Board of trustees shall be responsible for the custody of all records and properties of the trust and shall have power and authority for and on behalf of the Board of trustees to carry out the resolutions of the Board of trustees, to sign papers, receipts and documents, to receive and pay out monies, to draw, endorse, accept and negotiate cheques---

23.
